Instructions to authors

Sri Lanka Journal of Dermatology, 2021, 22: 102

The Sri Lanka Journal of Dermatology is published annually by the Sri Lanka College of Dermatologists. Material received for publication is assumed to be submitted exclusively to the Sri Lanka College of Dermatologists (SLCD) and becomes the copyright of the SLCD. All authors must give signed consent for publication. Original Articles should not exceed 2500 words, with no more than six tables or illustrations, and should have relevance to dermatology or allied sciences. Short reports of less than 750 words with only one table or illustration and not more than five references, clinical Case reports, and brief or negative research findings are also acceptable. Letters for publication should not exceed 400 words or contain more than five references.

Preparation of the manuscript

The manuscript should be typed in double line space in 12 pt on a A4 size file in MS Word with at least 2.5 cms margins all round. First page of the manuscript shoud contain the title of the article, the name(s) and initial(s) and post(s) held by each author at the time they did the work, and their current appointments. Articles should conform to the conventional structure of abstract, introduction, methods, results, discussion and references. The abstract should be given in a separate page and should not exceed 150 words and should set out the problem being addressed, what was done, the main findings and their implications.

Drug names should be given in the generic, and not as proprietary names. Spell out abbreviations when first used in the text. Give scientific measurements only in **SI units**, except for blood pressure (mmHg) and haemoglobin (g/dl). In addition conventional units can be quoted in parentheses. Use only Arabic numerals.

Statistical methods used should be given under methods and either described in detail or supported by references. Submit tables and illustrations separate from the text of the paper with the titles and their legends on another separate page. Tables should be simple and should not duplicate information in the text. Illustrations should be used only when data cannot be expressed clearly in any other way. When graphs or histograms are submitted, the numerical data on which they are based should be given. Staining techniques and the original magnification of photographs should be stated. Patients shown in photographs should have their identity concealed in some conventional way or if the face or eyes are the point of interest, written permission from the patient, parent or guardian, for reproduction in a journal should be submitted.

References

Keep references to a reasonable minimum and indicate them in the text only by Arabic numerals in the order of appearance, in superscript (e.g. The link between hypercholesterolaemia and coronary artery disease is now well established^{1,2}). At the end of the article give the full list of references in the correct numerical order with the name(s) and initial(s) of the author(s), followed by the title of the article, the title of the journal in full, the year and volume number, and the first and the last page numbers. Titles of books should be followed by the place of publication, the publisher, and the year, eg.

List all authors when there are six or fewer, when there are seven or more, list the first three then "et al".

Avoid using abstracts as references. "Unpublished observations" and "personal communications" may not be used as references. Manuscripts accepted, but not yet published may be included among the references, followed by (in press). Information from manuscripts not yet accepted may be cited only in the text followed by (unpublished observations). Authors must verify references before submitting article. Please refer to the 'Uniform requirements for Manuscripts submitted to biomedical journals' (New England Journal of Medicine 1991; 324: 424-428) for the style of citing references. Editors reserve the customary right of style, to shorten articles where necessary and to determine priority and time of publication.

Proofs and reprints

Manuscripts should have the name and e-mail address of the correspondingauthor to whom the proof is to be sent. Proof corrections should be kept to a minimum. Proofs sent to authors should be returned after correction within three days. Reprints will be supplied at cost. Details will be sent to authors with proofs. Cost of reproducing photographs and illustrations in colour may be charged to the author.
